## 15. Bailey Lane Level Crossing

At the previous meeting, it was resolved to write to the County Council Countryside Access Officer to request an update regarding the re-opening of the crossing further to the finding of the Inquiry (C22/96).

To note response received by email 17 November 2022: (DC&R is Development Control and Regulation Committee):

On the 7<sup>th</sup> November 2022 Network Rail informed me that they were in the process of compiling a 1980 HAs118A application to extinguish the railway crossing, which will address the points raised by the Inspector in her order decision and explain why she was incorrect in her suggestions and demonstrating that collective mitigations to reduce residual risk will not make the crossing safe for public use.

We have now received an application and I am seeking legal advice on how the County Council should proceed. Options are that Officers decline to process the application or a report is submitted to CCC's DC&R Committee with a recommendation to either make an order or to reject the application.

Therefore I am at present unable to give a time frame for when the crossing will be reinstated.

#### 16. Civic Matters – Remembrance Parade

The Remembrance Parade took place on Sunday 13 November. This is insured by the Town Council. To note that the Police will no longer provide road closures for Remembrance Parades. From now on, the Town Council needs to organise and pay for these.
